NOTIFICATION

Islamabad, the 21st June, 2001

S.R.O. 487 (D)/2001.—In pursuance of sub-rule (2) of rule 3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, the following method of appointment, qualifications, experience, age limits and other conditions are laid down for appointment to the post of Arabic Scholar (BPS-19) in the Ministry of Foreign Affairs, Islamabad.

METHOD OF APPOINTMENT

2. The above post shall be filled as follows :—

Provided that if no suitable person is available for initial appointment the post reserved for initial appointment shall be filled by transfer.

QUALIFICATIONS, EXPERIENCE AND AGE LIMITS FOR INITIAL APPOINTMENT

3. A candidate must possess the educational qualifications and experience and must be within the age limits mentioned against the post in the Schedule to this notification, provided that :—

- (i) the maximum age limit will be relaxed by 3 years in the case of candidates belonging to the Scheduled Castes, the Buddhist Community, the recognized tribes of the Tribal Areas, Azad Kashmir and the Northern Areas, in accordance with the instructions issued by the Government ;
- (ii) for government servants who have completed at least 2 years continuous government service, the maximum age limit will be relaxed by not more than 10 years up to the age of 55 years, wherever applicable ;
- (iii) the maximum age limit in case of released/retired commissioned officers of the Armed Forces of Pakistan will be relaxed up to a maximum of 10 years or by the number of years an officer has actually served the Armed Forces, whichever is less.

QUALIFICATION/CONDITIONS FOR TRANSFER

4. Appointment by transfer shall be made from amongst the persons holding appointment on a regular basis under the Federal Government in the same basic pay scale in which the post to be filled exists, provided that the person concerned possesses the qualifications and experience prescribed for initial appointment to the post concerned.

PROBATION

5. Persons appointed by initial recruitment or by transfer shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded, or if considered necessary, it may be extended for a period not exceeding one year as prescribed at the time of appointment. Appointment on probation shall be subject to the provisions of section 6 of the Civil Servants Act, 1973.
