NOTIFICATION

Islamabad, the 6th June, 1983

S.R.O. 51(G.E)/38:

In pursuance of sub-rule (2) of rule 3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, the following method, qualifications and other conditions are laid down for appointment to the post of Senior Librarian, BPS-18 under the Ministry of Foreign Affairs.

2. Method of Appointment.—The post of Senior Librarian, BPS-18, shall be filled initially by promotion of existing incumbent of the post of Librarian in BPS-17 provided that he has rendered 5 years service in B-17, and subsequently by initial appointment.

3. Qualifications, Experience and age limits for Initial Appointment.—A candidate must possess the educational qualifications and experience and must be within the age limits as mentioned against the post concerned in the schedule to this notification.

Provided that the maximum age limits will be relaxed by 3 years in the case of candidates belonging to Scheduled Castes, Buddhist Community, recognised tribes of the Tribal Areas, Azad Kashmir and Northern Areas (Districts of Gilgit, Skardu and Diamir), in accordance with the instructions issued by the Establishment Division.

Provided further that for Government servants who have completed at least 2 years continuous Government service, maximum age limits may be relaxed by not more than 10 years up to the age of 55 years wherever applicable.

4. Probation.—Persons appointed by initial appointment shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded, or if considered necessary, it may be extended for a period not exceeding one year as may be prescribed at the time of appointment. Appointment on probation shall be subject to the provisions of section 6 of Civil Servants Act, 1973.

5. This notification issues with the concurrence of the Establishment Division, and Federal Public Service Commission vide their O.M. No. 5-1/87-R. 3, dated 14th March, 1988 and letter No. F. 12-15/88-S; dated 26/4/1985, respectively, and supersedes, Ministry of Foreign Affairs' Notification No. Rules-2/8/81, dated 13th February, 1982.
