NOTIFICATION

No. Rules-2/8/81.—In pursuance of sub-rule (2) of rule 3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, the following method, qualifications and other conditions are laid down for appointment to the posts of Assistant Librarian (Grade 16) and Librarian (Grade 17) in the Ministry of Foreign Affairs :—

2. **Method of Appointment.**—The post of Assistant Librarian (Grade 16) shall be filled by direct recruitment and the post of Librarian (Grade 17) by promotion and failing promotion, by direct recruitment.

3. **Condition for Promotion.**—Promotion to posts in column 1 below shall be made by selection from amongst the persons who hold the posts specified in column 2 on regular basis and possess the qualifications and experience prescribed in column 3 :—

Name of the post	Persons eligible	Condition of eligibility
Librarian (Grade 17)	Assistant Librarian (Grade 16)	3 years' service in Grade 16.

4. **Qualification, Experience and Age-limits for Direct Recruitment.**—A candidate must possess the educational qualification and experience and must be within the age-limits as mentioned against the post concerned in the schedule to this notification.

Provided that the maximum age-limits will be relaxed by 3 years in the case of candidates belonging to Scheduled Castes, Buddhist Community, Recognised tribes of the Tribal Areas, Azad Kashmir and Northern Areas (Districts of Gilgit, Skardu and Diamir) in accordance with the instructions issued by the Establishment Division.

Provided further that for Government servants who have completed at least 2 years' continuous Government service, maximum age-limit may be relaxed by not more than 10 years up to the age of 55 years.

5. Probation.—Persons appointed by promotion or direct recruitment shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded, or, if considered necessary, it may be extended for a period not exceeding one year as may be prescribed at the time of appointment. Appointment on probation shall be subject to the provisions of Article 6 of Civil Servants Act, 1973.

6. This notification issues in supersession of the Ministry of Foreign Affairs' Notification No. S. R. O. 788(K)/65 dated 12th September, 1965 and with the concurrence of the Establishment Division and Federal Public Service Commission.
