5. 1 [Computer Proforma](#) Duly filled in from column 4 to 12
6. Original Pakistani ID Card/s (CNIC/NICOP) with a clear photocopy
7. Copies of current Pakistani Passports (Page 1 and 2)
8. Original Naturalization/Assurance Letter issued by the Immigration Department of Hong Kong SAR/Macau
9. Copy of Hong Kong Identity Card
10. 06 Fresh photos with Blue background and write names on the back side of photos.
11. Copy of payment and submission receipts of NADRA's ID cancellation
12. Names of the minor children, if any, declared at column 10 of Form 'X' Please provide copies of their Birth Certificates, Pakistani ID Cards / Registration Form issued by NADRA and copies of Passports
13. In case of Taiwan, it should be translated into English and duly attested by the Notary Public
