I am directed to refer to M/o Foreign Affairs' letter No. Adv.(FA)-1/2016, dated 11 January 2016, on the captioned subject and to convey the following instructions vis-à-vis Deportation Policy/SOPs issued, vide this Ministry's letter of even number, dated 29.12.2015:

- i. Time-line of 15 day's advance notice for deportation has been reduced to 03 days, subject to completion of due verification process.
- ii. All IMPASS Offices in Pakistan Missions abroad are authorized to issue ETDs on old formats/forms till availability of new ETD forms, to clear the backlog of deportees.
