ORDER

Islamabad the April 20, 2021

S.R.O. No.513(I)/2021 dated April 20, 2021 - WHEREAS the United Nations Security Council vide its resolutions nos. 1556 (2004), 1591 (2005), 1651 (2005), 1665 (2006), 1672 (2006), 1679 (2006), 1713 (2006), 1779 (2007), 1841 (2008), 1891 (2009), 1945 (2010), 1982 (2011), 2035 (2012), 2091 (2013), 2138 (2014), 2200 (2015), 2265 (2016) and 2340 (2017) concerning Sudan have imposed certain sanctions measures against actors operating in Darfur, and certain individuals and entities under Chapter VII of the United Nations Charter;

AND WHEREAS the United Nations (Security Council) Act, 1948 (XIV of 1948) enjoins upon the Federal Government to apply certain measures for giving effect to the decisions of the United Nations Security Council;

NOW, THEREFORE, in exercise of the powers conferred by Section 2 of the United Nations (Security Council) Act, 1948 (XIV of 1948), the Federal Government is pleased to order that the indicated list entry annexed to this order has been deleted from the 1591 Committee List in accordance with the relevant paragraphs of the aforesaid Resolutions with immediate effect.
